Minutes August 4, 2009

Steve moved to open the meeting at 6:02 pm, seconded by Francis and approved.

Steve asked to mention again the motion made at the July 21, 2009 meeting to waive the Inventory Penalty for all property owners if the form and missing information for the Inventory form is received by August 1, 2009.

Francis moved to accept the minutes and non-public minutes (x2) for July 21, 2009, seconded by Randy and approved.

Chief Kay advised the police cruiser needs work due to transmission issues, which is under warranty, and will need to be repaired. The Chief said a resident has asked for a no parking sign for Ellsworth Hill Rd. The Chief will review and advise more next week and Selectmen will make decisions at that time.

Chief Kay reviewed the garbage dumped near the Transfer Station and discussed the issue with the Selectmen.

Selectmen authorized Cale Weeks to do the mowing around guardrails and will be paid straight time even if done on the week end. Cale also agreed to obtain his CDL license by October 1, 2009.

Selectmen authorized the repair of the lawnmower/tractor and will have the highway department transport it to Blackmount for repair.

Steve Welch inquired about the Dodge property, which has been deeded. Selectmen advised the property owner loses all their rights after three years. At this time, the Selectmen do not have a plan to sell the property.

Selectmen advised they signed Intent to Cut for Paul Davis Jr. last week and signed Intent to Cut this week for Jim Heal M/L 10-01-02 after the logger posted a bond.

Francis moved to add insurance to the deeded properties the Town has acquired; this was seconded by Steve and approved.

Selectmen approved a driveway permit for Glass on Atwell Hill Rd, M/L 05-01-26.

Francis moved to change the acreage on the Herlihy property M/L 04-02-31 to 28.11 acres, seconded by Randy and approved.

Selectmen agreed to add a penalty if the town did not receive the completed inventory after sending the required letter.
