Francis asked the Board who the Level 4 supervisor was for the Transfer Station. The Board stated they were unfamiliar with the various levels and will look into this.

Chief Wally Trott, stated there was nothing new to report this week.

Peter Holden (Holden Engineering & Surveying, Inc.) discussed with the Board regarding beams leftover from the Dufour Bridge Project. Mr. Holden stated that a small town in Vermont would like to purchase these beams. There are approx. 4 pieces that could be used. Chris requested that the Town of Vermont requesting the beams, draft a request for offer to purchase, and no liability for removal, items are as is, and Pete agreed and approved. Funds will be placed into the Town's General Fund.

Janice Thompson questioned the need for lead testing of the river since the bridge has been disassembled on the Gayle Paige property. The Board asked Ellie if the testing has been done for the month of August. Ellie was unsure and said she would check into this. George stated that the river bed and bank was protected with a plastic like material during the dismantling process. Chief Trott suggested that maybe the river could be tested above the site of the bridge construction and below site to compare testing numbers.

Francis questioned the need for a non-public meeting held on July 9th with FEMA. The Board stated it was a meeting with the State of NH OEP. Francis suggested in the future to hold a non-public meeting only when needed. The Board thanked Francis for his import.

Francis inquired about the new TC/TC Deputy support person. The Board stated that the TC/TC has hired a Deputy to fulfill the RSA requirements.

Janice Thompson asked the Board for a status update regarding the Town Hall repairs. Chris read a recent email received from Eric Merluzzi, regarding septic system size, town hall capacity, and issues related to the well. Chris wondered if we could possibly use a holding tank with an alarm.

Chris motioned to open the meeting at 6:00 pm, seconded by Pete and approved.

Chief Wally Trott stated there was nothing new to report this week for the Police Dept. He did ask Jeff Ames if he saw the article in the newspaper regarding the bicycle accident in town. The article gave a special thank you to the police, fire, and the ambulance for the smooth and wonderful service provided in caring for the patient.

The Chief introduced Ray Rheume who was asked to give an estimate for repair and creation of Town Signs (town office, Hamilton Field, and welcome signs at the North and South entrance to the town). Ray presented drawings of the proposed Town Office and Hamilton Field sign. The Board received and reviewed them with the public. It was agreed upon to move forward with constructing the signs. The Board will check with Cary Whetherbee, NH DOT to see what the requirements are for road signage and measurements for roadside placement. Francis was asked by the Board regarding financial help from the Historical Society for the Town Welcome signs. Chris motioned to move forward with the four signs, seconded by Pete and approved. Mr. Rheume stated that there is a 10 year warranty on all his signs. He will repair at his cost if needed.

Mark Stetson from Avitar discussed the re-evaluation and stated it went smoothly. The Town's total evaluation went down in pricing. Mark met with several property owners regarding their property re-evaluation. The DRA has been in to review Town files regarding current use, and found missing information of about 5%. Indications are that the town will probably not pass. Suggestions will be to update the files of the current use property owners who have missing info. The Town's in much better shape than they were 5 years ago per Mark. Mark said the Fairpoint Lawsuit is still active and no decisions or settlements have been made for Pole placements, permissions, and agreements. There has been some discussion of costs to town's people eventually, but nothing at this time. Mark says, it's not huge dollars but it's a value increase. Mark gave the Board the completed manual regarding the re-evaluation. Overall Mark stated the process went smoothly.

Chris opened the meeting to Privilege of the Floor. Janice Thompson spoke with the Board in regards to her concerns of having water testing done at the bridge area. Chris noted her concerns and said water testing is important.

Janice also questioned about the Town Hall and when an insurance inspection would happen. Catherine spoke with John Nies, of Integrated Insurance Solutions, who anticipates the inspection will take place sometime in the Fall of 2016.

Janice questioned the MOA for the bridge. The Board felt the contract was okay and signed it.
