Chris motioned to open the meeting at 6:02 pm, seconded by Ray and approved.

Selectmen reviewed:

The requested "Right to Know" site plans and documentation on the Dollar General Development, by Bohler Engineering.

The Select Board began by saying that they don't believe the Town has any say in this matter that it is a private sale by a land owner. They opened the floor for discussion.

Glenn Campbell was thanked by The Board and asked to give a brief overview of what he has for information and knowledge of the project.

Glenn began his discussion that in 2002-2012 this area of Rt. 25A was a historical preservation. He also mentioned that he and many others have witnessed this area soon to be known as the Dollar General site to have taken on much water from the last two devastating FEMA storms. Glenn believes that after a close examination of the plans, the contractors will be raising the land approx. 6 inches, which he believes will cause a dam affect. DOT has proposed a bigger culvert in the area to measure 18" instead of the current 15" one there. He went on to say that a larger culvert, is for increased potential of more water. Glenn said that if the road (Rte. 25A) washes out, then a detour by means of Town roads, wear and tear traveling, will be at the expense of Town resident and their tax dollars. The abutters and Town Residents are wanting an independent water study done. Glenn said this has nothing to do with the request of the Select Board, it's his own perception. A letter will be drafted up by Glenn, approved by the Select Board and sent to the All-Terrain Bureau.

Mr. Francis Muzzey says he doesn't believe that they did a thorough enough study on the land by footage. He also thinks there should be a bond on the development in case it doesn't work out.

Mr. Glenn Campbell said the study could possibly cost the Town money.

Mr. Quentin Mack believes this land does not qualify as a State Floodplain or Wetland area. He mentioned that the Town needed simple regulations (such as a ZBA and the Selectmen disagreed and said the Town did not want this. Mr. Mack said it should be asked at Town Meeting. Mr. Muzzey said the Planning Board was against this.

Select Board Ray said he had spoken with NHMA Legal service and the Town legally cannot stop the process now with adopting zoning regulations at this time or it could possibly end in a lawsuit.

Ray said he had a conversation with the Town of Bristol's Manager and they said nothing can be done to stop the Dollar General from happening. At best, they could possibly work with them and have an esthetic appearance done.

Select Board Chris read a letter of correspondence between Duane Brown and Kay Bailey. Ms. Kay Bailey said she responded to the letter to increase the size. Mr. Richard Bailey spoke about his concerns with the additional water and culvert size.

Mr. Glenn Campbell went on to mention he heard the basement (Pease/Blodgett homestead) always took on water, and Mr. Muzzey added not to forget the percolation process on the property.

After a quick inspection of the culverts in the area, by a couple residents, they observed the culvert under Rt. 25A, was clogged with debris.

Mr. Craig Pasco said that it was inexpensive land.

Mr. Quentin Mack asked Ray if He will relay and support this. Ray agreed to draft a letter up and see if an independent water study could be done. Chris said he was on the fence and going to remain neutral.

Mr. Francis Muzzey said that he recommends sending to various State Officials or organizations the same letter they are sending to request an independent study.

Mr. Richard Borger Jr., asked who owns the property. The reply was Russell and Katrina Blodgett, which is under agreement. Mr. Mike Santom asked, who was developing. The reply was Liscotti Development, located in Leominster, Massachusetts.

Mr. Noel King questioned, how many washouts if any, and if anyone knew how much waterfall was noted in past, and if there was any backups/standing water in the surrounding areas.

Ray asked who was the NHDOT contact, the reply was District 2 out of Enfield, NH. He also asked Glenn if he would be willing to help draft the letter asking for this water study. Glenn agreed and it will be drafted and done at the Voting Session on March 13, 2018.

Ray motioned to move to the Oath of Office for the Conservation Commission, seconded by Chris and approved at 6:45 pm.

This concluded the Conservation Commissioners who were sworn into office at 7:10 pm.

Ms. Marni Kozak questioned The Board of Selectmen on the pole placement on East Side Rd. near the Friendship Bridge. The Board asked Kevin Gilbert, Road Agent to look into possibly having this pole removed. There is no power or lights attached at the time. Mr. Gilbert agreed to make a call to the New Hampshire Electric Co-op for clarification on the project and help the residents understand what is going on.

After an examination of the petitions and a brief discussion, Chris motioned to honor the Town's petitioned request to make the Riverside Park and Hamilton Field/Swim hole for Residents Only, seconded by Ray and approved. Mr. Palmer Koelb was happy to hear this.

The Board listened to other comments on the possibilities of a Farmer's Market in Town, and the cleaning out of the Old Town Hall. The Board recommended the Admin. Assistant to check with the Primex (Property Liability) Insurance Co. on the safety and risk management of doing so.

Ray motioned to come out of the public session and move into a Non-Public Session at 7:53 pm, seconded by Chris and approved.

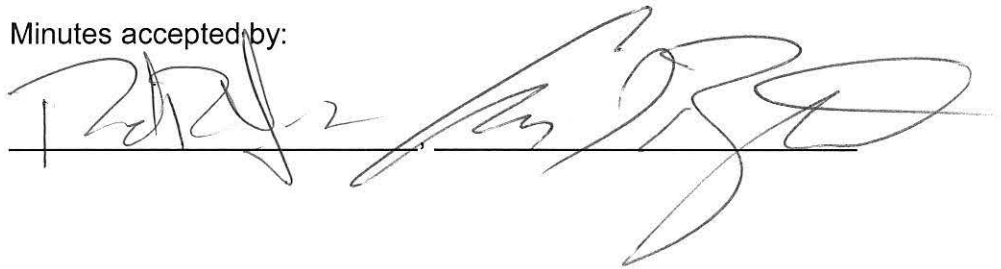

Selectman Ray asked if the Historical Society allows the use of their bathroom during special events in Town or at the Old Town Hall.

Selectman Pete noticed an error in the Yield Tax Cover Sheet and pointed out the need for a correction to the Admin. Assistant. Pete also read an email discussing a phishing scam with emails and wanted to be sure it was shared with the Tax Office.

Dean Hanson was invited to speak on behalf of the Legion Speedway (Racetrack). Mr. Hanson and his wife Jane stopped in and signed the contract and paid the \$25.00 fee for the permit license. Mr. Hanson was offered a copy of the contract, and ordinance, along with a receipt for his payment. The Board questioned if there had been change in the hours or days, that the races were being held. Mr. Hanson denied any change other than a request for an extension in hours. Mr. Hanson requests the curfew to be granted from 10:00 pm to 11:00 pm. He said he was rained out 5 times

last year and had many interruptions, causing delays and unhappy participators. He feels he has given back to the Community with an increase from \$17,000 to \$20,000 in revenue. The Chief spoke up and said that Mr. Hanson has been very cooperative. The track has improved and is more family oriented. The Hansons said the Kids Club allows the kids to pay a \$5.00 fee for first time visit, and subsequent visits are free up to age 11 yrs. old. They involve the children when they can, give many bicycles away each race season, have bike parades and allow them on the track during trophy winnings. The Race track is a non-alcohol and non-problematic venue. The Board understood the request and asked the Admin. Assistant to contact the Pine Have Campground owners to see how they felt about this extension, before granting the permission or making an amendment to the ordinance. It was mentioned to the Hansons that they could request in writing, an extension for special occasions / fireworks.

Chief Trott gave an update from the Police Dept. He's been quite busy with a couple of investigations and the usual patrols and safety measures. He's also done some recent trainings. The Chief did mention that there are still concerns for the general public of scammers. A particular one going around now is someone calling stating they are from the IRS, during Tax Season. Be cautious.

Arlene Patten, Admin. Assistant gave an update from the Selectmen's Office. The PA28 Inventory Forms have been mailed and are already coming back, fast and furious. Ms. Patten went on to mention that a 30-day Appointment for a Health Officer has taken place. The Select Board did nominate the Rumney Health Officer, and the State NHDHHS Appointed Rebecca Bordonaro to temporarily assist with an inspection, or until one has been appointed to the Town fulltime. The Select Board did ask Ms. Patten to contact the Health Officer for her credentials and what the State Requirements were that she held. It was also asked what the Town of Rumney offers as a stipend to the Health Officer. The Board said they would be willing to do a \$200 retainer, and \$50 per additional inspection, if she was okay with that. The Admin Assistant will mention this to Ms. Bordonaro and invite her to the next Board Meeting for discussion.

Kevin Gilbert, Road Agent gave an update. He said, the bridge on East Side Road has been repaired. He is also working with NHEC to have the pole on East Side Road (on walking bridge side) to be removed. BG Frazier is on vacation. Selectman Ray asked Kevin Gilbert, Road Agent to reach-out to Jen Meade with a plan. The Road Agent said that he's been in discussion with the State in regards to the Red List Bridge on Frescoln Road and believes there is no need to replace the culverts. The State asked for pictures and they will send someone out to do an inspection. The Road Agent also noted that all roads have been posted now for about a month. He's been working with the Loggers, allowing them early morning hours to work while the roads are firm, but then must not return until late April or so, and is keeping the Chief apprised in the early morning.

Mr. Glenn Campbell said that Jim Folsom (his new attendant) is due to attend a Basic Training on April 19th in Shelburne, VT. He says that Mr. Folsom has a few hours left training with him. Mr. Campbell spoke about the grants on the recycle equipment (bailer/compactor), need for the Transfer Station. Selectman Ray asked about matching contingencies or future costs in the budget. Glenn spoke of the recycle monies in CR Funds. He said the only cost would probably be for an electrician. Ray asked that Glenn speak with Deb Vlk before collecting any monies as donations for the compactor/bailer. Clean up has been taking place at the Transfer Station. Mud season is here and the yard needs some grading done soon.

The Board extended an invitation to: Privilege of the Floor

Mr. Glenn Campbell addressed The Selectmen about the Conservation Commission. He would like to know which lands/forest the Conservation Commission will be overseeing. Also, would this include the parks, wetlands, and the Plummer Forest? After a brief discussion, Selectman Ray made a motion: as of today, March 27, 2018 the Conservation Commission would oversee the Plummer's Forest and the Town's adjoining Forests, motion seconded by Pete and approved by Pete and Doug.

Selectman Ray asked that the Administrative Assistant to send a thank you note to Ms. Ellie Murray, for her years of service, as the Chair to the Conservation Commission.

The Board was questioned when the Parks would be cleaned up and if the costs was going to be covered by FEMA?

Mr. Glenn Campbell questioned The Board if a clean up crew could begin in the Old Town Hall. The Admin. Assistant said she heard from the insurance company. Primex was hesitant on giving a reply on the safety of the Old Town Hall Building, whereas they don't know all the details. They requested we contact the 3-G Contractors who gave the work estimate and report. Also, we should at least call the Fire Chief and ask for a code inspection. Mr. Palmer Koelb would like to see the square-dancing, return back to the Town Hall before it dies out altogether. Selectman Pete motioned to allow a group of individuals to clean the 2nd floor, seconded by Ray and approved. The Fire Chief will be contacted to a follow up per Primex.

Selectman Ray spoke of the 4H Club and that the members would like to consider adopting either the Hamilton or Riverside Parks for a community service. The 4H is also interested in a 10x10 piece of Town property for a vegetable garden. It was mentioned that possibly the land on the corner of East Side across from the Old Town Hall could be used. Mr. Glen Campbell mentioned that down on the lower level, behind the Historical Property was a very nice area and away from the busy intersection. More private and less trafficked area. Ms. Kay Bailey said that the Historical Society meets on the 3rd Thursday of April at 7:00 pm. Ray said the Club would have someone come ask permission.

The first official Conservation Commission meeting will be held March 29, 2018 at the Town Offices, Selectmen's Board Room. Mr. Campbell said that Linda Brownson, Chair for States Conservation Commission and Norman Pilcher, Conservation Commissioner would both be happy to help and assist this group.

Ms. Kay Bailey mentioned to The Board that she found an error in the minutes dated back to January 2, 2018. The Board asked her to submit the addendum changes in writing and they would be reviewed and published in the next business meetings.

driveway was speculative and not proven to be a large vehicle, but in fact was a small personal vehicle of another resident.

Selectman Ray motioned to go into a Non-Public meeting at 7:47 pm, seconded by Pete and approved.

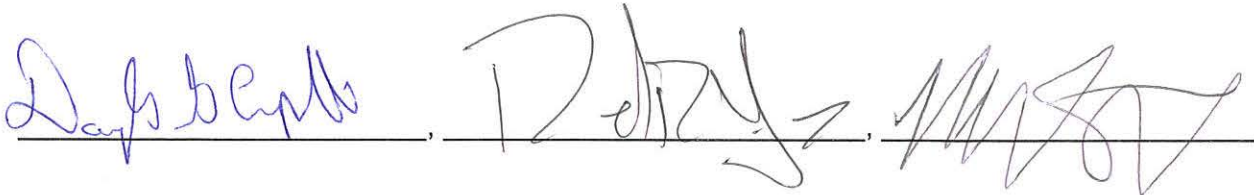
