**May 4, 2004 Minutes Selectmen's Meeting**

Present: Ed Baker Chairman, Palmer Koelb, Francis Muzzey, and Janet Woolner

Also Present: Police Chief Schneiderhan, Police Chief Main from Rumney, Ellie Murray, Gini Gove, John Baker, Roy Ames, Bobby Cass, Rick Vincent, Gary Karp from DRA, and Hannah Towel

Francis moved to open the meeting at 6:03 PM. This was seconded by Palmer and approved.

Ed moved to accept the Minutes of April 27, 2004. This was seconded by Francis and approved.

Chief Main agreed to bill the Town of Wentworth as a subcontractor for Rumney Officers to do detail at the Pines Racetrack. Rumney will pay the officers and are responsible for withholding deductions. Francis moved to pay the Town of Rumney \$35/hr for racetrack coverage retaining \$5/hr for Wentworth paperwork). This was seconded by Palmer and approved.

Selectmen authorized Chief Schneiderhan to have a receiver for TV communications installed on the Town Office property.

Bobby provided a highway update. Selectmen authorized a basin to be put in on the Wentworth Common and Calcium Chloride put on Beech Hill, Atwell Hill & Cape Moonshine.

Bobby expects the broom next week and will use it for 10 hrs of sweeping @ \$95/hr. Selectmen asked Bobby to put gravel on the Old School House property. Selectmen agreed Bobby could work on the driveway in front of the Fire Dept (\$2500 is for the Asphalt and up to \$500 for Bobby's labor).

Selectmen signed the Abatement denial for Tucker M/L 05-08-16, and letters to Lewis Young and Stephanie Jones.

Ed moved to go into non-public session per RSA 91-A:3, II (c) at 6:30 PM. This was seconded by Palmer and approved. Francis moved to come out of non-public at 6:55 PM. This was seconded by Ed and approved. No decisions were made.

Gary Karp reviewed and answered questions on Assessment Review Guidelines for the 2004 Certification.

Ed moved to exempt the Wentworth Baptist Church M/L 01-02-09. This was seconded by Francis and approved. Selectmen approved the Elderly exemption for Julia Pease M/L 08-01-09, denied the exemption for Beek M/L 05-01-14.

Francis moved to authorize the assessor to make a change in the base assessment. This was seconded by Ed and approved.

Ed moved to adjourn the meeting at 9:20 PM. This was seconded by Francis and approved.

Selectmen agreed to waive the highway department billing for the Wentworth Elementary School and will just send a letter to the school advising charges. Selectmen approved Baker River Valley Snowmobile Club M/L 13-04-15A as a charitable organization and exempt from property taxes. This was seconded by Palmer and approved.

Lewis Young M/L 10-05-04, 07 advised the Selectmen he would remove the junk cars from his property within two weeks. He has made arrangements with someone from Groton to remove the cars for him.

Selectmen approved septic designs for Witter M/L 02-05-01, Dunfey M/L 13-03-09 and Delsart M/L 08-13-18.
