October 28, 2004 Minutes Selectmen's Meeting

Palmer moved to open the meeting at 6:07 PM. This was seconded by Francis and approved.

Selectmen discussed the chimney repairs at the old Town Hall.

Francis moved to reschedule next weeks Selectmen's meeting from Tuesday (due to the elections) to Wednesday at 9:00 AM, 11/3/04, for the purpose of signing payroll and checks.

Chief Robert Schneiderhan advised the selectmen that he is in charge of Police Details and the amount to be charged the Wentworth School for dances. Francis read from the October 19, 2004 minutes the motion stating the Town functions are to be policed during the regular 40-hour week. Discussion continued about Francis not signing future checks for detail. John Millican suggested the school board discuss these issues with the Police Dept. Francis said he still would not sign any future checks for detail of this nature.

Wayne Vlk stated if there is money in the budget the check should be signed and paid. Janice Thomson said she and other town's people are happy with the current police coverage. Tim Minear said, if the Police Chief isn't over budget, there should be no issue. Noel King said the Chief could spend the budget allotted. Chief Schneiderhan presented Francis with copies of several RSA's and said Francis, in the past, has been out of order, out of control, has harassed him, and is guilty of defamation of character.

Tim Minear inquired about the criteria for the Veterans exemption and will call the office for additional information.

John Millican presented a petition to the Selectmen, which he read aloud, for Cape Moonshine & Atwell Hill Rd stating the roads are not in good shape. Francis moved to do what they can to correct the road situation. This was by seconded by Palmer and approved.

Palmer moved to accept the minutes of October 19, 2004. This was seconded by Francis and approved.

Francis moved to appoint Palmer as Chairman. This was seconded by Palmer and approved.
